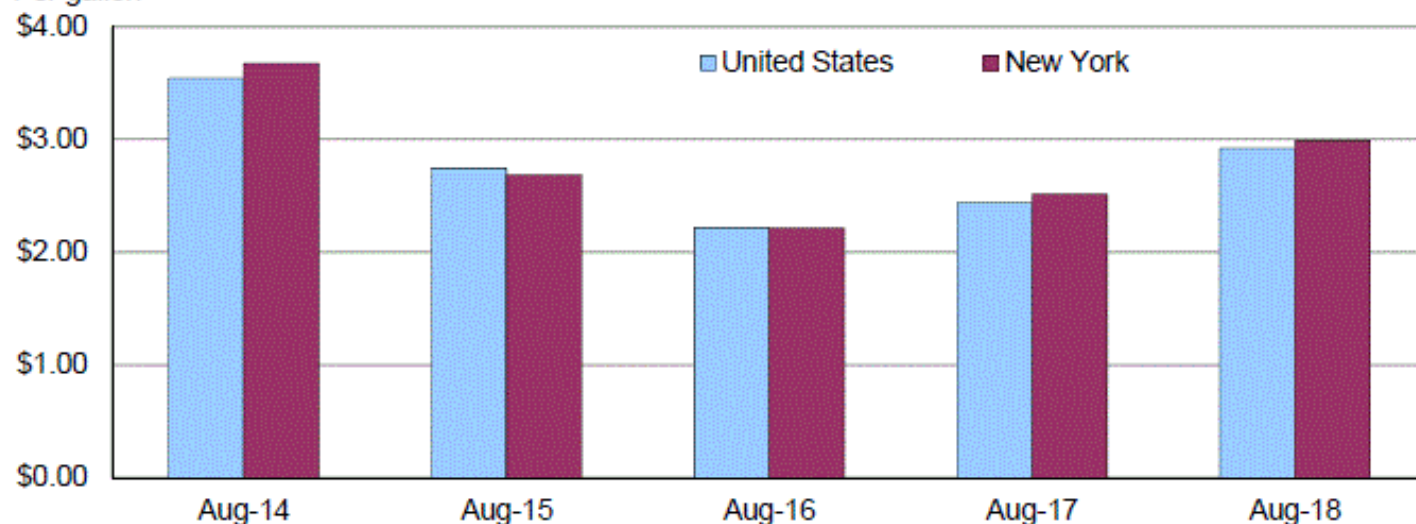
Average Energy Prices, New York-Newark-Jersey City – August 2018

Gasoline prices averaged \$2.988 per gallon in the New York-Newark-Jersey City area in August 2018, the U.S. Bureau of Labor Statistics reported today. Chief Regional Economist Martin Kohli noted that gasoline prices were up \$0.476 compared to last August when area households paid \$2.512 per gallon. Electricity prices averaged 20.8 cents per kilowatt hour (kWh), up from the 20.1 cents per kWh paid in August 2017. The average price of utility (piped) gas, at \$1.220 per therm, was more than last August’s price of \$1.096. (Data in this release are not seasonally adjusted; accordingly, over-the-year-analysis is used throughout.)

At \$2.988 a gallon, the price of gasoline in the New York area compared to a \$2.919 national average in August 2018. One year earlier, consumers in the New York area also paid close to the national average. For the past five years, the local price of a gallon of gasoline in August has been within 4 percent of the national average. (See [chart 1.](#))

Chart 1. Average prices for gasoline, the United States and New York-Newark-Jersey City, 2014–2018 (as of August)

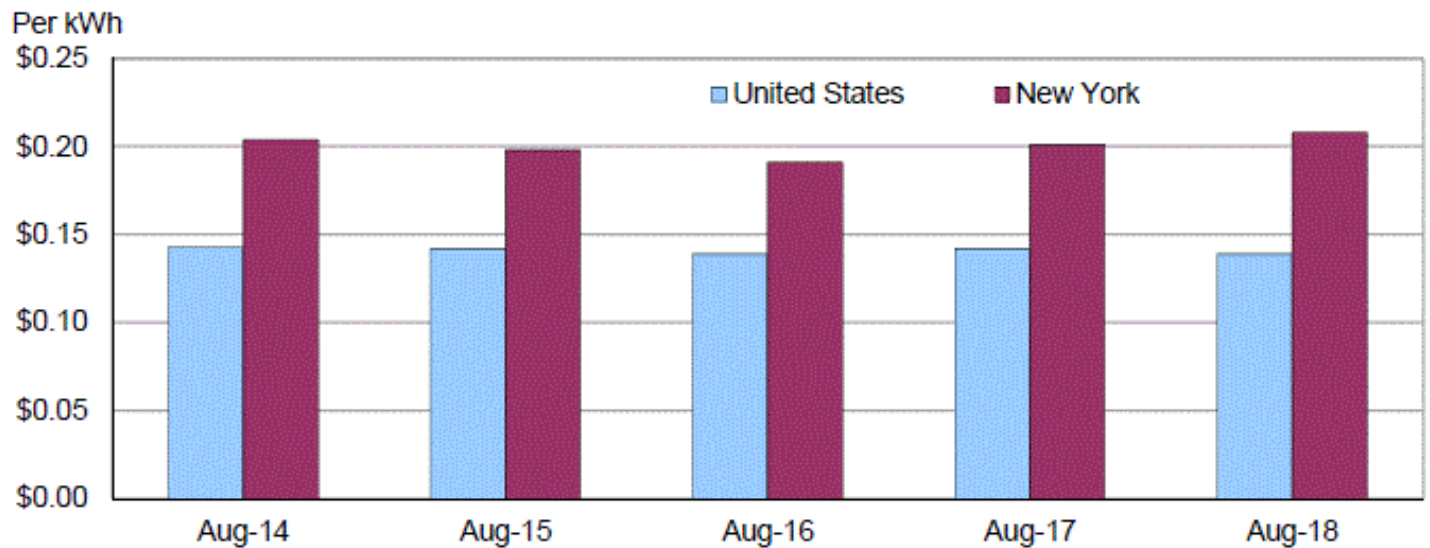

The 20.8 cents per kWh New York households paid for electricity in August 2018 was 50 percent more than the national average of 13.9 cents per kWh. Last August, electricity prices were 42 percent higher in New York compared to the nation. In the past five years, electricity charges for local area consumers in August were 37 to 50 percent more than the national average. (See [chart 2.](#))

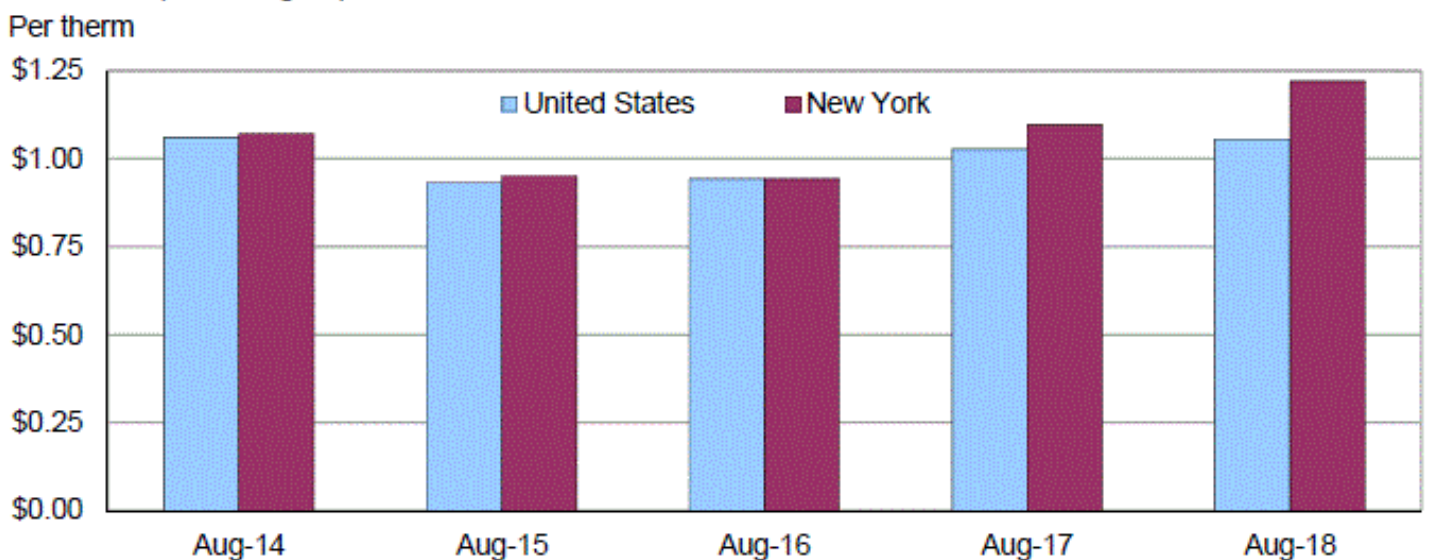
Chart 2. Average prices for electricity, the United States and New York-Newark-Jersey City, 2014–2018 (as of August)

The average price paid in August 2018 by New York area consumers for utility (piped) gas, commonly referred to as natural gas, was \$1.220 per therm, 16 percent more than the national average of \$1.055. In 2017, area consumers paid 7 percent more than the national average, but from 2014 to 2016, the per-therm cost for natural gas in the New York in August was close to the U.S. average. The New York-Newark-Jersey City, N.Y.-N.J.-Pa., Core Based Statistical Area includes Bronx, Dutchess, Kings, Nassau, New York, Orange, Putnam, Queens, Richmond, Rockland, Suffolk, and Westchester Counties in New York; Bergen, Essex, Hudson, Hunterdon, Middlesex, Monmouth, Morris, Ocean, Passaic, Somerset, Sussex, and Union Counties in New Jersey; and Pike County in Pennsylvania.

The Consumer Price Index for September 2018 is scheduled to be released on Thursday, October 11, 2018 at 8:30 a.m. (ET).

Technical Note

Average prices are estimated from Consumer Price Index (CPI) data for selected commodity series to support the research and analytic needs of CPI data users. Average prices for electricity, utility (piped) gas, and gasoline are published monthly for the U.S. city average, the 4 regions, 9 divisions, 2 population size classes, 8 region/size-class cross-classifications, and the 23 largest local index areas. For electricity, average prices per kilowatt-hour (kWh) are published. For utility (piped) gas, average prices per therm, are published. For gasoline, the average price per gallon is published. Average prices for commonly available grades of gasoline are published as well as the average price across all grades.

All eligible prices are converted to a price per normalized quantity. These prices are then used to estimate a price for a defined fixed quantity. The average price per kilowatt-hour represents the total bill divided by the kilowatt-hour usage. The total bill is the sum of all items applicable to all consumers appearing on an electricity bill including, but not limited to, variable rates per kWh, fixed costs, taxes, surcharges, and credits. This calculation also applies to the average price per therm for utility (piped) gas.
