Employer-Reported Workplace Injuries and Illnesses in Arizona – 2019

Over 62,000 nonfatal workplace injuries and illnesses were reported among Arizona’s private industry employers in 2019, resulting in an incidence rate of 3.0 cases per 100 full-time equivalent workers, the U.S. Bureau of Labor Statistics reported today. (See [table A.](#)) Assistant Commissioner for Regional Operations Richard Holden noted that Arizona was among 20 states that had an incidence rate of total recordable cases (TRC) significantly higher than the national rate of 2.8. (Arizona was 1 of 41 states and the District of Columbia for which statewide estimates are available. See Technical Note at the end of this release for more information about the survey.)

Arizona’s findings from the 2019 Survey of Occupational Injuries and Illnesses include:

- TRC incidence rates in private industry ranged from 1.6 in financial activities to 4.0 in leisure and hospitality. (See [table 1.](#))
- Two supersectors, with 40 percent of private industry employment, accounted for 49 percent of the occupational injuries and illnesses: trade, transportation, and utilities and education and health services. (See [table 2.](#))
- In private industry, the TRC injury and illness incidence rate ranged from 1.2 for establishments employing fewer than 11 workers to 3.4 for establishments employing 11 to 249 workers. (See [table 3.](#))
- Arizona’s private industry TRC rate of 3.0 in 2019 was not significantly different from 2018. (See [table 4.](#))

Private industry injury and illness case types

Of the 62,900 private industry injury and illness cases reported in Arizona, 32,600 were of a more severe nature, involving days away from work, job transfer, or restriction—commonly referred to as DART cases. These cases occurred at a rate of 1.5 cases per 100 full-time workers. Fifty percent of the DART cases in Arizona were incidents that resulted in at least one day away from work, compared to 57 percent nationally.

Other recordable cases (those not involving days away from work, job transfer, or restriction) accounted for the remaining 30,300 cases in Arizona, at a rate of 1.4. In comparison, the national rate for other recordable cases was 1.2.

In Arizona, the natural resources and mining industry supersector experienced significant decreases in both the TRC and DART rates from the previous year. The other services, except public administration industry supersector experienced a significant decrease in the TRC incidence rate. No other private industry supersector had a significant change in the TRC or DART rate over the year.

In 2019, approximately 59,300 (94.3 percent) of private industry recordable injuries and illnesses were injuries. Workplace illnesses accounted for an additional 3,600 recordable cases.

State and local government injury and illness cases

In the state and local government sector in Arizona, 11,800 injury and illness cases were reported in 2019, resulting in a rate of 4.7 cases per 100 full-time workers. Nationally, the rate was 4.6. Eighty-six percent of injuries and illnesses reported in Arizona's public sector occurred among local government workers.

State estimates

Private industry and public sector estimates are available for 41 participating states and for the District of Columbia for 2019. The private industry injury and illness rate was statistically higher in 20 states than the national rate of 2.8 cases per 100 full-time workers, lower in 14 states and in the District of Columbia, and not statistically different in 7 states. Caution should be taken when comparing rates among different states as some differences can be attributed to different industry composition within each state.

Coronavirus (COVID-19) Pandemic Impact on the Survey of Occupational Injuries and Illnesses

Technical Note

The Survey of Occupational Injuries and Illnesses (SOII) is a Federal/State cooperative program that publishes estimates on nonfatal occupational injuries and illnesses. Each year, approximately 200,000 employers report for establishments in private industry and the public sector (state and local government). In-scope cases include work-related injuries or illnesses to workers who require medical care beyond first aid. See the Occupational Safety and Health Administration (OSHA) for the entire [recordkeeping guidelines](#). The SOII excludes all work-related fatalities as well as nonfatal work injuries and illnesses to the self-employed, to workers on farms with 10 or fewer employees, to private household workers, to volunteers, and to federal government workers.
